## PRESERVE



INCE ITS FOUNDING nearly four decades ago, the American Battlefield Trust, together with its steadfast supporters and partners, has succeeded in preserving forever more than 58,000 acres of hallowed battlefield land.

In 2023, the Trust completed 49 transactions at 29 battlefields in 11 states, saving a total of 2,088 historic acres. Among these preservation victories were 20 acres of the Jacob Avey Farm, some of the most hallowed ground at Antietam (Md.), almost 154 acres at Shiloh (Tenn.), nearly 179 acres at the Wilderness (Va.) and many more. A full listing of acres saved can be found in the adjacent column.

To start the year, the Trust came into possession of 117 acres at Buffington Island, Ohio, marking the 25th state in which the organization has preserved land and ushering in an exciting milestone — permanently protecting land in half the states in the Union.

Preservation projects launched in 2023 spanned multiple theaters in both the Revolutionary and Civil Wars. The past year saw the highly anticipated continuation of our crucial efforts in the "Gaines Mill – Cold Harbor Saved Forever Campaign" with its fourth phase, the "Cavalry Charge" tract. The Trust was also tremendously excited to announce the launch of a new \$3 million fundraising campaign to preserve the remainder of land at the former Gettysburg Country Club. Alongside The Conservation Fund, the Trust will propel efforts more than 15 years in the making to preserve 15 acres of hallowed ground that played a key role on the first day of fighting at the Battle of Gettysburg.

Thanks to our wonderful members and partners, the Trust also succeeded in saving key Revolutionary War sites, including almost 260 acres at Newtown, N.Y., and small, but critical parcels in Charleston and at Hobkirk Hill, S.C. These victories successfully advanced our goal of preserving 2,500 acres of Revolutionary War battlefield land in celebration of the upcoming 250th anniversary of the American Revolution. In addition to these important achievements, the Trust also moved forward with launching the transformational "Washington's Legacy" plan to revitalize the

landscape at the Princeton Battlefield while expanding interpretive experiences.★

Between January 1, 2023, and December 31, 2023, the American Battlefield Trust completed 49 individual transactions, protecting a total of 2,087.58 acres at 29 battlefields in 11 states. This land is valued at \$27,328,951, but thanks to a host of matching grants and other revenue sources, the Trust secured its preservation through a net cash outlay of only \$7,536,992 — a leverage factor of 3.6-to-1.

# EDUCATE



OLSTERING the phenomenal preservation work you helped to make possible, our team has also continued to make great strides in another key element of our mission – educating the public about what happened on our nation's most hallowed ground and why it still matters today.

America's battlefields remain some of the very best outdoor classrooms there are to educate future generations about our shared history. In 2023, the Trust's History Field Trip Grant Program made it possible for more than 6,000 students and teachers to visit battlefields and historic sites. Since its creation, this important program has helped more than 45,000 students and educators to visit our nation's most historic places and walk in the footsteps of the men and women who shaped America's history. Five new virtual field trips also made their debut in 2023, taking some 425,000 learners to Charleston, S.C., Boston, Mass., New Orleans, La., Baltimore, Md., and Vicksburg, Miss.

The Trust's virtual and in-person Teacher Institutes both marked important successes in 2023 as well. Together, the institutes helped to provide professional development for 1,335 educators from nearly every U.S. state and multiple countries. Each of these educators will in turn impact thousands of students over the course of their careers.

2023 also proved to be a record high year for audience engagement with our educational content – our website witnessed more than 19 million visits, at least 80% of which were from students, and our videos received more than 13 million views. From an enhanced Civil War Battle Maps App that allows users to geolocate themselves on a battlefield to new augmented reality experiences and more, our arsenal of online educational content continues to grow. In 2023 alone, the Trust's Education and Digital teams added hundreds of new articles, biographies, maps, battle pages, and more than 230 new videos to our website. Of particular note is the Trust's brand new "Step Into History" series, which has been nominated for a 2023 Anthem Award.

The past year also brought a new cohort of our Youth Leadership Team. These extraordinary students continue to work diligently on the battlefield preservation, education, and visitation projects they are undertaking in their local communities, inspiring all those they encounter with their passion, creativity, and appreciation for America's story.★

# INSPIRE

**I**N ADDITION to preserving hallowed battlefield land and producing top quality educational resources, the Trust also worked enthusiastically throughout 2023 to inspire a deeper appreciation for our nation's history and heritage.

The year brought several meaningful and exciting opportunities for our donors to experience battlefields and to witness the work they've made possible firsthand, including a Donor Thank You Weekend in Atlantic Beach, Fla., in February, our Annual Conference in Franklin, Tenn., in May, and our Grand Review in Williamsburg, Va., in October.

The Trust's 27th annual Park Day event in April brought more than 3,200 volunteers to 108 sites across 27 states to participate in hands-on cleanup projects that rejuvenated and prepared our nation's battlefields and historic sites for visitors throughout the year.

This year also witnessed new and ever-increasing development threats, which compelled the Trust to ramp up its advocacy efforts. In Orange County, Va., the Trust joined forces with local nonprofits and private citizens to oppose a mega-development that would mar the landscape near the Wilderness Battlefield. The Trust also became involved with efforts to prevent a proposed gas station in the heart of the Chancellorsville Battlefield and joined forces with other passionate preservationists to advocate against plans that would build the world's largest data center complex adjacent to the Manassas Battlefield — on some of the very land where the modern battlefield preservation movement was born.

In December, the Trust launched two of its most exciting new ventures: The first, a traveling exhibition of the *American Revolution Experience*, created in partnership with the Daughters of the American Revolution, will travel to scores of libraries, historical societies and museums throughout 2024; the second, the Trust's first ever "Prize for History," sponsored entirely by a generous donor, will award a \$50,000 prize annually to an exceptional work of military history or biography, showcasing the rich research potential of historic battlefields.

Along with our land preservation victories and educational offerings, the Trust continues to work tirelessly to advance our mission — and we could not be more grateful for the support of individuals like you as we strive together to preserve, educate and inspire.★


